



Sample Language for Wills and Trusts

Having an updated will ensures that your wishes are carried out after you pass away. It is your opportunity to provide for your loved ones and support the missions that are important to you. This sample language can be used in most wills.

General or Specific Outright Bequest:

I give, devise, and bequeath to Alabama 4-H Club Foundation (Employer Identification Number 63-0457929), a tax-exempt organization located at 244 Duncan Hall, Auburn, AL 36849, the sum of \$_____ (or real or personal property herein described), to be used for the general purposes of the Alabama 4-H Club Foundation at the discretion of its Trustees* or specific purpose or function of the Alabama 4-H Club Foundation.

General or Specific Percentage:

I give, devise, and bequeath to Alabama 4-H Club Foundation (EIN 63-0457929), a tax-exempt organization located at 244 Duncan Hall, Auburn, AL 36849, %_____ of the rest and residue of my estate to be used for the general purposes of the Alabama 4-H Club Foundation at the discretion of its Trustees* or specific purpose or function of the Alabama 4-H Club Foundation.

General or Specific Residuary:

I give, devise, and bequeath to Alabama 4-H Club Foundation (EIN 63-0457929), a tax-exempt organization located at 244 Duncan Hall, Auburn, AL 36849, the rest and residue of my estate to be used for the general purposes of the Alabama 4-H Club Foundation at the discretion of its Trustees* or specific purpose or function of the Alabama 4-H Club Foundation.

General or Specific Residuary:

In the event that {insert name or names of spouse, children, sibling, or heirs} shall not survive me, or shall die during the administration of my estate within _____ days from the date of my death, or as a result of a common disaster, then I give, devise, and bequeath those beneficiaries' shares of my estate to the Alabama 4-H Club Foundation (EIN 63-0457929), a tax-exempt organization located at 244 Duncan Hall, Auburn, AL 36849, the rest and residue of my estate to be used for the general purposes of the Alabama 4-H Club Foundation at the discretion of its Trustees* or specific purpose or function of the Alabama 4-H Club Foundation.

***If Leaving Money for a Specific Purpose:**

Because of the uncertainty of the future, we suggest the following language when leaving a gift with a specific purpose:

It is my preference that the gift remains used for the specified purpose. However, I understand and agree that if, at some future time, it is no longer practical in the judgment of the Board Members of the Alabama 4-H Club Foundation to use the gift for the purpose intended, the Board Members shall have the right to use the gift for whatever purpose they deem necessary and reasonable in accord with the intent described herein.

Examples of Specific Purposes or Functions of the Alabama 4-H Club Foundation

Alabama 4-H Center, Alabama 4-H Programs, Alabama 4-H Educational Trips, Alabama 4-H Camp Scholarships, Alabama 4-H Leadership Programs, Alabama Scholarships, Alabama 4-H County Specific Programs.
